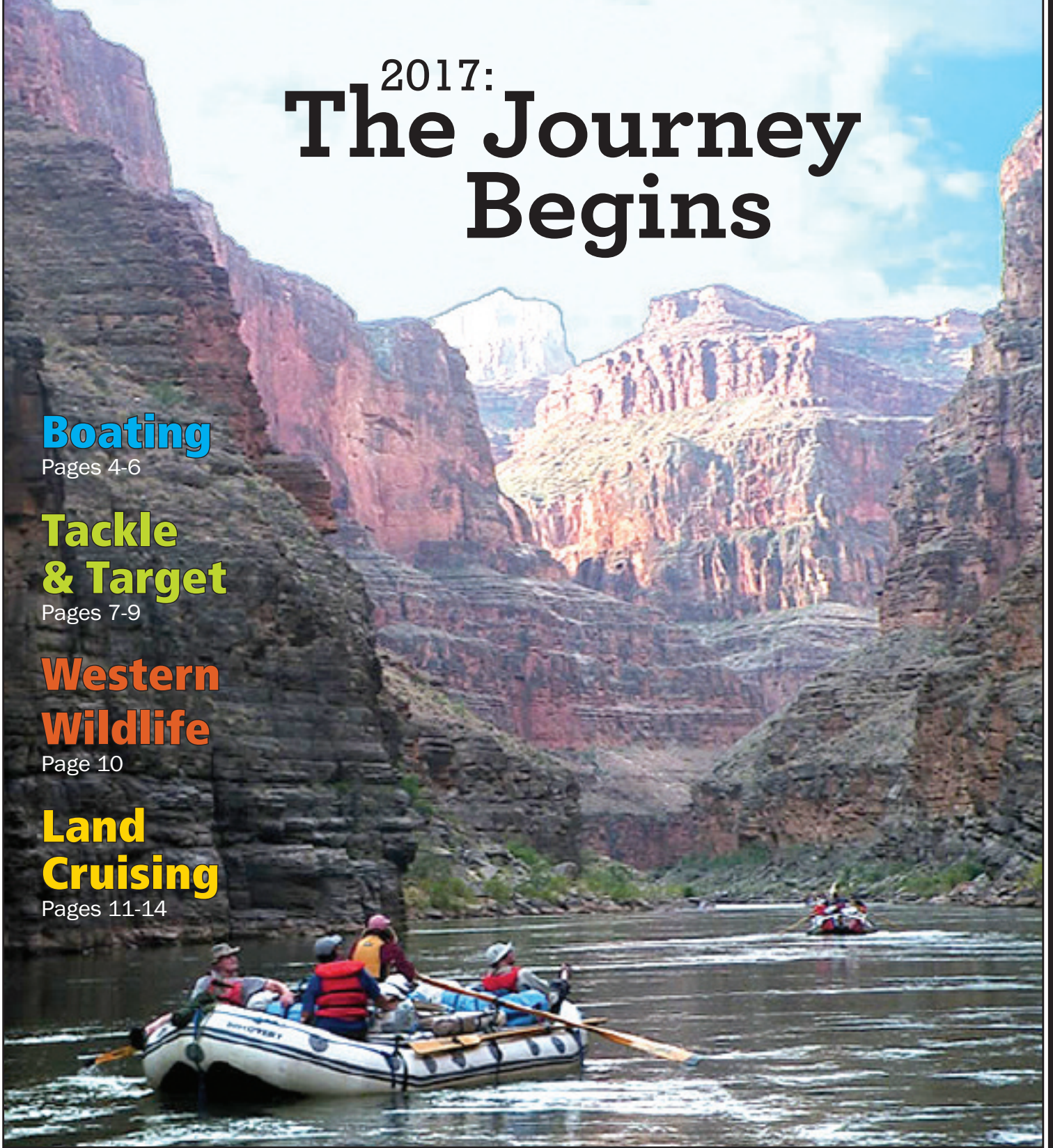

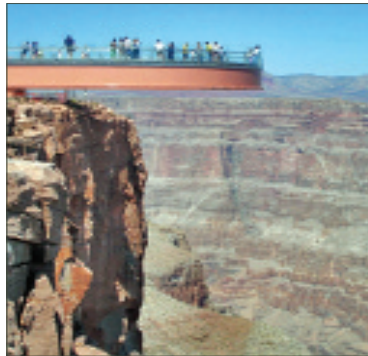




## Ring Out The Old; Ring In The New Grand Canyon National Park Celebrates Centennial Success; Looks Ahead To 2019

Grand Canyon National Park celebrated its 6 millionth visitor as its final National Park Service Centennial event.

The distinction went to the Johnson family from Las Vegas, Nevada. Delighted to be part of the celebration, James and Abigail Johnson and their kids Sophia and Elijah were first time visitors to Grand Canyon National Park. "At first I didn't think it was real", exclaimed Sophia, "but I'm really

happy we're the 6 millionth!"

Grand Canyon's 6 millionth visitors were greeted at South Entrance Station and led to Park Headquarters where Superintendent Chris Lehnertz, park staff, and community members welcomed them and presented them with gifts from Grand Canyon Association, Xanterra, Tusayan Chamber of Commerce and Bright Angel Bikes.

## May Your 2017 Journey Be Stellar

Famed for its dramatic rapids and canyons, the Colorado is one of the most desirable whitewater rivers in the United States, and its Grand Canyon section – run by more than 22,000 people annually – has been called the "granddaddy of rafting trips".

Grand Canyon trips typically begin at Lee's Ferry and take out at Diamond Creek or Lake Mead; they range from one to eighteen days for commercial trips and from two to twenty-five days for private trips.

Private (noncommercial) trips are extremely difficult to arrange because the National Park Service limits river traffic for environmental purposes; people who desire such a trip often have to wait more than 10 years for the opportunity.

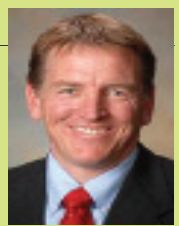

## Waterfowl hunters encouraged to practice boating safety

Many hunters utilize boats, kayaks and other watercraft to battle through wind, cold, dust, rain or snow to arrive at the "special" hunting spot. To ensure a safe trip, hunters are encouraged to remember these seven following tips:

1. **Leave a float plan** with family and friends, detailing where you're going and when you plan to return.
2. **Don't overload the vessel.** Make sure it can safely transport you, your gear and maybe your dog, if it's coming along.
3. **Distribute weight evenly** inside your vessel.
4. **Use care while loading and while moving around.**

Most boats used during hunting are flat-bottomed and tend to tip over quite easily.

5. **Always wear a life jacket.** Consider placing one on your dog as well, as cold water can cause their muscles to cramp while in the water.
6. **Transport firearms safely** with the action opened, unloaded and cased whenever possible.
7. **Cold-water immersion can be deadly** so dress appropriately and if you fall overboard, climb back into or on top of the boat. If you cannot, stay near the vessel, use decoys, oars or anything floating nearby to help stay afloat.

## Register your watercraft

## Know the Rules: Learn to identify "Navi-Aids"



Arizona law enforcement agencies write many citations for "failure to obey navigation laws." You can help ensure the safety of all on the water by learning to identify these common navigational aids.



**Information**  
Squares indicate where to find food, supplies, repairs, etc. and give directions and other information.

### Controlled

Circles indicate a controlled area such as speed limit, no fishing or anchoring, ski only or no skiing, or "slow, no wake."



### Exclusion

Crossed diamonds indicate areas off-limits to all vessels such as swimming areas, dams, and spillways.



### Danger

Diamonds warn of dangers such as rocks, shoals, construction, dams, or stumps. Always proceed with caution.

## Other Non-Lateral Markers

**Safe Water Markers** are white with red vertical stripes and mark mid-channels or fairways. They may be passed on either side.



**Inland Water Obstruction Markers** are white with black vertical stripes and indicate an obstruction to navigation. You should not pass between these buoys and nearest shore.

## Mooring Buoy

Mooring Buoys are round and white with a blue horizontal band and are found in marinas and other areas where vessels are allowed to anchor.

Note, the following actions are illegal:  
◆ Willfully damaging, removing, interfering with, or tying up to a navigation buoy not intended for mooring  
◆ Mooring, anchoring, or fastening to shore for more than 14 consecutive days any vessel on public waters.

## Need to borrow a life jacket?

Visitors to lakes Pleasant, Havasu, Saguaro or Mohave needing a life jacket can borrow one at Life Jacket Loaner Stations near each lake's boat ramps.

Stations contain jackets for infants to adults. **Please return** the jackets so they can be used by others.

**BENEFITS BOATERS** — The enactment of a federal bill supporting water infrastructure improvements will also benefit boat owners, says BoatUS

## Water Infrastructure Improvements For The Nation Will Benefit Boaters

*The Act includes funds for Everglades restoration.*

BoatUS, the nation's advocate for boat owners, applauds passage of a bipartisan bill signed by President Obama on December 16 that will provide critical funds for water-resource infrastructure projects at emerging harbors, channels, locks and dams.

The Water Infrastructure Improvements for the Nation Act (WINN), which

encompasses the Water Resources Development Act (WRDA) legislation of 2016, authorizes the needed investment in the maritime and waterways transportation system and provides flood protection for communities.

Boaters will like the bill as it supports waterway-access projects, navigation and fisheries improvements, and provides maintenance funds for harbors of refuge. It also creates a pilot program to look at beneficial uses of dredge material in hopes of lowering costs, and funds the

### NEW WATERCRAFT FOR CHRISTMAS?

## AZGFD Offers 10 Tips For New Boaters

'Tis the season to head out on the water and if a boat, kayak or other personal watercraft was on your Christmas list this holiday season, and Santa agreed, the Arizona Game and Fish Department wants to make sure your inaugural voyage is a safe one.

Whether you're planning to take a new watercraft out for some sightseeing or to do some fishing, all new and veteran watercraft users are encouraged to remember the following 10 tips to remain safe on the water:

- **Always wear a life jacket.** Life jackets aren't just a good idea, they are required by state law for anybody 12 years old and younger when the boat is underway. There must also be at least one life jacket available for everyone aboard.
- **Register your watercraft.** Make sure the vessel's registration is current before heading out on the water. It's one of the most important boating requirements needed to operate a watercraft on Arizona waterways. The registration fee is determined by watercraft length and ranges from \$20 to \$66 for Arizona residents and \$100 to \$495 for non-residents. Those needing to renew their watercraft registration can do so online at [www.azgfd.gov/](http://www.azgfd.gov/) boating.
- **Take a boating and watercraft safety course.** Learn how to practice safe boating techniques and to respond in the event of an emergency by completing a hands-on safety course.
- **Learn and follow the "navigation rules of the road."** In Arizona, most citations are issued for navigation rule violations. Navigation rules and water markers such as buoys are in place to help avoid collisions on the water.
- **Research where you plan to take your watercraft.** It's always a great idea to learn everything you can about the waterway you're heading off to before you get there. Call ahead and check maps to



learn about underwater obstacles and shallow zones.

- **Make sure you have the proper supplies.** Make sure there is plenty of drinking water, snacks and food aboard if the plan is to be on the water for extended periods of time. Also be sure to leave a float plan with family and friends, detailing where you're going and when you plan to return; and to pack sunscreen, a first-aid kit, fire extinguisher and cell phone or marine radio.
- **Do not install or use unapproved lighting.** Rope lighting, "party" lighting and various other types of decorative lighting may not meet U.S. Coast Guard certification requirements and could increase the likelihood of a collision. Regardless if the lighting was installed before the vessel was purchased, decorative lighting could violate U.S. Coast Guard rules.
- **Do not drink alcohol or use drugs while operating a watercraft.** Just as it's illegal to operate a vehicle on the roadway under the influence of alcohol or drugs, it's equally illegal to do so on the water. Alcohol use is the leading known contributing factor in fatal boating accidents nationwide in 2014, according to the U.S. Coast Guard.
- **Cold-water immersion can be deadly so dress appropriately and if you fall overboard, climb back into or**

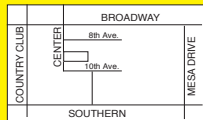

## These Are Two Must-Have Forms For Every Boat Buyer Or Seller

Behind most successful used-boat transactions, there's a Purchase Agreement and Bill of Sale that clearly spell out how the boat was bought or sold. The BoatUS Consumer Protection Department now offers both of these documents at no cost online.

"A Purchase Agreement is necessary if you intend to buy a boat, but require that certain things must be done before you will accept the boat, such as a satisfactory marine survey, specific repairs, and the ability to finance or insure the boat," said BoatUS Consumer Protection Director Charles Fort.

"It also describes both parties' obligations. Once a buyer accepts the boat, the bill of sale is used as proof of purchase. You can download and print both forms 24-hours a day."

Fort also added that while the two forms were designed to meet the needs of most buyers and sellers, they may want to seek legal advice if there are any questions about whether the forms are appropriate for their situation.

## BoatUS Winterizing Guide Is Free

*Even in the Southwest, freezing can be a problem.*

Water that is mistakenly left in a boat's engine block to freeze over the winter is sure to become an expensive repair bill come springtime. As the ice expands, it can crack the block and ruin the motor, damage fiberglass, split hoses, or destroy a boat's refrigeration system.

To prevent a mishap while putting the boat away this season, Boat Owners Association of The United States (BoatUS), a boating advocacy, services and safety

group offers the free 15-page "Boater's Guide to Winterizing."

The online brochure addresses the reasons for more than 95 percent of the freeze claims handled by the BoatUS Marine Insurance Program. Included are sections on boat storage, engines and outdrives dos and don'ts, winterization contracts, green winterizing, as well as preparing boat plumbing. A winterization checklist is also included.

## Eight Ways To Avoid Problems At The Boat Repair Shop

For over 25 years the BoatUS Consumer Protection department has helped Boat Owners Association of The United States members resolve disputes with repair facilities. The vast majority of shops do the job right, but sometimes they — or boat owners — make mistakes. To see what went wrong and to possibly learn from others, BoatUS has surveyed its BoatUS Dispute Resolution files to identify eight trouble spots that boaters needing work done should know:

**1. Finding a shop:** Word of mouth is still king. Having American Boat & Yacht Council (ABYC) and Better Business Bureau (BBB) certifications are also two good signs. Boaters can also check out the BoatUS Consumer Protection Database for complaints filed by BoatUS members.

**2. Get it in writing:** Get a written estimate before work begins, and remember that it is based on an approximation of how much the job will cost. If work may go beyond the estimated price, you can always direct the shop to obtain your authorization before proceeding with unforeseen repairs. Remember, if it's not in writing, there's no way to confirm the work was requested.

**3. Is there a guarantee for the work?** 30-, 60-, or 90-days are all typical. Ask if parts and labor are included. Don't wait until after the warranty expires to check the repairs.

**3. Remove valuables:** Bring small electronics, personal items and fishing gear home.

**4. Take photos:** It's always good to take a few "before" time-stamped photos of your boat in the shop (your smart phone may have this feature built-in or there are Apps available). Accidents do sometimes happen, and you may need be-

fore and after damage photos to show the shop damage took place and possibly file an insurance claim.

**5. Languish at your peril:** Avoid having your job pushed to the back burner by staying frequently informed about ongoing repairs. While there are often legitimate delays due to seasonality, parts sourcing, weather, and personnel, if you think you are getting put off, you probably are. Cut losses and find another shop. (Tip: For larger jobs, ask the shop to periodically email you pictures of work in progress. It may help keep the job on schedule.)

**6. Inspect, inspect, and inspect:** When picking up the boat after completion of repairs, ensure each bit of repair work matches the actual invoice. If you do have a dispute with the final bill,

you're in better legal shape if you pay it in full, preferably on a credit card, and then

file a complaint with the shop and/or your credit card company.

7. **A note about end-of-season repairs:** Sea trials must take place during the warranty period, which has sometimes caused problems for BoatUS members who put their boats away for the winter

before ensuring the repairs are satisfactory. Any open issues found in the springtime will likely come out of the boat owner's wallet.

**on top of the boat.** If you cannot, stay near the vessel and use oars or anything floating nearby to help stay afloat.

• **Buy a fishing license.** If fishing is even part of the day's adventure, anyone 10 years of age and older dipping a line into the water must have a valid fishing license. General fishing licenses cost \$37 for residents and \$55 for non-residents per year. To purchase one and for information on various hunt and fish license combinations, visit [www.azgfd.gov](http://www.azgfd.gov) and click "Buy a License."

Those needing to register their watercraft can save time by renewing online at [www.azgfd.gov](http://www.azgfd.gov) and clicking "Boat Renewals." US Army Corps of Engineers (USACE) for Everglades restoration, among other projects.

"Like a highway bill for boaters, passage of the WINN/WRDA is great news for American boaters," said BoatUS Government Affairs Manager David Kennedy. "With the renewed attention to the nation's infrastructure, BoatUS thanks Congress and the President for acting to keep our waterways open and channels clear."

According to a statement released by the House Transportation Committee, the WINN/WRDA also aims to cut red tape by requiring more timely approvals, accelerates the permit process on non-federal modifications to USACE projects, and bolsters local participation in construction and maintenance of water infrastructure. "These infrastructure improvements have been proposed at the local level in cooperation and consultation with the Corps, and have national economic and environmental benefits," said the statement.

In addition to BoatUS, the bill had the support of the National Marine Manufacturers Association, Ducks Unlimited, the US Chamber of Commerce, Marine Retailers Association of America, American Sportfishing Association, Center for Coastal Conservation, and American Waterways Operators.

## As Of Jan. 1, New Fishing Regulations Have Taken Effect

Some new fishing regulations took effect on Jan. 1. Be sure to look for the full 2017-18 Arizona Game and Fish Department fishing regulations online around the first of the year. Also, the new fishing regulations booklet will be available at all AZGFD offices and license dealers in early January.

Here are the changes:

- Reduce the daily trout bag limit to five at the Colorado River from Lake Mead to California-Nevada boundary (including Lake Mohave and Willow Beach).
- Reduce the daily bag limits to two bass, minimum size 13 inches; and 4 catfish in any combination at Whitehorse Lake.
- Change the season and daily bag limit from Glen Canyon Dam to the Paria Rifle to two rainbow trout; artificial fly and lure only; barbless hooks only.
- Close the Kino Environmental Restoration Project to fishing. The Kino Environmental Restoration Project is in Tucson (Pima County).
- Change the daily trout bag limit to two, any species combination at Frye Mesa Reservoir.
- Allow the use of fathead minnows caught on site to be used as bait at Riggs Flat Lake.
- Create a year-round bow-and-arrow season for catfish at Apache, Canyon and Saguaro lakes, with a special regulation daily bag limit of five catfish in any combination.
- Catch and release regulations for largemouth bass at Pena Blanca Lake and Dankworth Pond will have sunset and will no longer be in effect. The statewide limit of six bass will apply.

## Input Can Shape Target-Shooting Policy For Sonoran Desert National Monument

*BLM to conduct public meetings Jan. 19-21; comment deadline is March 15.*

The Arizona Game and Fish Department encourages the public, especially those interested in recreational target-shooting, to provide their input on management alternatives for the Sonoran Desert National Monument near Gila Bend.

The Bureau of Land Management's (BLM) Phoenix District Office recently announced the release of a draft Environmental Impact Statement (EIS) and Resource Management Plan (RMP) amendment that kicked off a 90-day public comment period. The BLM is collecting public input before moving forward in the decision-making process.

As part of the process, three public meetings have been scheduled:

**Jan. 21: Noon-4 p.m., Dorothy Powell Senior Adult Center, 405 E. 6th St., Casa Grande, AZ 85122.**

Written comments can be mailed to Wayne Monger, BLM's project manager, at: 21605 N. 7th Ave., Phoenix, AZ 85027. Comments also can be faxed to (623) 580-5623, or e-mailed to [BLM\\_AZ\\_SDNMtargetsighting@BLM.gov](mailto:BLM_AZ_SDNMtargetsighting@BLM.gov). All comments must be received prior to the close of the 90-day public comment period March 15.

Under a March 2015 federal court order, the BLM was required to re-analyze the impacts of recreational target-shooting on the monument. A range of alternatives was developed based on public comments and suggestions received during the scoping process earlier this year. The draft EIS and RMP amendment analyze the impacts of each alternative. The RMP website is <http://bit.ly/SDNMtargetsighting>.

The Arizona Game and Fish Depart-



ment recognizes the importance of protecting public access and enhancing outdoor recreational opportunities, including recreational target-shooting. ## These Are The Top Five AZ Fishing Holes For This Winter

*And, remember that you can purchase your fishing license online and help conserve wildlife in the process.*

In Arizona, winter doesn't have to mean sending boats and rods and reels into hibernation. While outdoor recreation opportunities across many U.S. states shut down during the season of freeze, Arizona rolls on with trout stockings and water temperatures just warm enough to convince fish to bite during the holidays.

Although fishing tends to slow a tad this time of the year, there are some spots that are winter-friendly.

Here, then, are the Arizona Game and Fish Department's top-five fishing holes for this winter:

### 5. Alamo Lake

Alamo is a western Arizona dandy that can heat up quickly during the winter. At any given time from Nov.-Feb., Alamo can have some of the best crappie fishing in the state.

### 4. Parker Canyon Lake

Not only does Parker Canyon Lake in southern Arizona have great access with an abundance of shoreline options, but also its water temperatures remain cold enough to keep trout active throughout the day — not just during the late evening and early mornings. Parker Canyon Lake is stocked with trout through the winter.

### 3. Lees Ferry

Lees Ferry on the Colorado River is cold in the shadow of a canyon, but fishing opportunities remain steady. Winter is traditionally the spawning period for this world-class wild rainbow trout fishery in northern Arizona that provides the awe-

### Tip Of The Week

Bartlett Lake in the Tonto National Forest can be a great place for winter crappie and bass. Some of the best crappie fishing can be done in the cold of the morning — then anglers can switch to bass. Consider throwing crankbaits and spinnerbaits with a slow presentation.

Trailers on spinnerbaits, and slow-rolling across the rock stringers, can work well at times. Once you get a feeling for where the bass are holding, switch to the finesse style of drop-shotting.

### The Reel Deal

For six months, nights were becoming longer, peaking Wednesday, Dec. 21, at 3:44 a.m. — the first day of winter.

As we cross that peak and daytime gradually lengthens toward spring, it's time to focus on what species and waters are best for winter fishing. First, our Community Fishing Program waters are being stocked with trout. Second, we have some new fishing regulations coming into effect Jan. 1 — see article with the details in this issue.

Also, be sure to check the ADOT Web site for road conditions before traveling this weekend. Ice fishing is not recommended due to unstable conditions of ice.

inspiring gateway to the Grand Canyon.

Catching trout in the rushing Colorado River along the spectacular red sandstone cliffs of the Marble Canyon Gorge is an experience beyond compare.

### 2. Lake Havasu

This giant, shallow, solunar bowl in the desert heats up quickly during a warm winter sun and has a large variety for sport-fish.

The world record 5-pound, 12.8-ounce monster redear sunfish was taken last year from Lake Havasu by Hector Brito.

Lake Havasu has some of the best bass fishing in the nation and water temperatures stay relatively warm during the winter.

The “West Coast of Arizona” hardly experiences winter.

### 1. Lower Salt River

Anglers get the unique experience of stream fishing for trout in the desert. The Lower Salt River (pictured), just minutes from some of the Valley of the Sun's population centers, is stocked with trout throughout the winter and offers good shoreline fishing options as well. A Tonto Pass is required.

Try nightcrawlers, small spinners, Kastmasters and flies. You might be able to catch some bass or sunfish in the deeper holes.

### Purchase Online

You'll need a fishing license — purchase them online, 24/7. They're good for 365 days and help conserve wildlife for future generations.

### Nets And Waders: Working For You

*(This new section will periodically show what our fisheries biologists have been doing in the field to improve fishing in Arizona.)*

We recently conducted our annual electro-fishing survey on the backwaters of the Imperial Division of the Colorado River to gather data on relative abundance, size, growth of fish and to detect any large-scale changes in the fish population.

The largemouth bass population appears to be doing well — the largest sampled was 23.9 inches and 9.5 pounds. More than 20 percent of the largemouth bass captured during the survey were 15 inches or larger. A high number of young-

of-the-year largemouth were sampled as well — possibly an indication for a future robust population in this area.

A total of 2,235 fish were sampled at 17 survey stations — including 206 largemouth bass. Other species collected included bluegill and redear sunfish, black crappie, warmouth sunfish, threadfin shad, gizzard shad, blue tilapia, common carp, striped bass, flathead catfish, and channel catfish.

# Here's A 'Berry Good' Trout Recipe To Try After Your Next Catch

Trout have been stocked in “core” Community waters, and more are being caught and stocked in higher elevation lakes. If you are successful, we suggest heading to the kitchen to try this delectable recipe.

## Pan-Seared Trout With Blackberry Sauce

**BY JOHNATHAN O'DELL**  
Serves 5  
Prep Time: 10 minutes  
Cook Time: 15 minutes

**Ingredients:**

- 2 pounds boneless trout fillets with skin on
- 2 tablespoons olive oil
- Salt
- Black pepper
- 1 tablespoon unsalted butter
- 1 tablespoon crushed garlic
- 2 cups blackberries
- 1 tablespoon sugar
- 1 tablespoon lemon juice
- 1 teaspoon grated ginger
- 1/4 cup water

**Directions:**

In a small saucepan, melt butter over medium heat. Add garlic and sauté for about a minute. Add blackberries and stir as they heat up and begin to break apart

and render liquid in the pan. Then add sugar, lemon juice, ginger and water and stir while continuing to break up berries for about 5 minutes.

Preheat a frying pan on medium-high heat. Drizzle oil over fillets, then salt and pepper them to taste. Place fillets, skin side down, in the frying pan. Cook until skin becomes crispy with golden-brown edges (approximately 3–5 minutes). Turn fillets over and cook until done (depending on thickness, approximately 3–5 minutes). Transfer fillets to plates and top with blackberry sauce.

# Sea Shepherd, Mexican Navy Team Up To Catch Poachers; Fishermen Arrested

*Six illegal fishing boats were apprehended by the Mexican Navy after being tracked by the M/V Farley Mowat in the Sea of Cortez.*



**LOS ANGELES** – Dec. 28 – Six fishing boats engaged in illegal activities were spotted by Sea Shepherd Conservation Society in Mexico's Sea of Cortez, ending in their arrest by the Mexican Navy.

On December 12 Sea Shepherd's M/V Farley Mowat located poachers on radar before confirming their identities with binoculars. The six fishing boats were working together, using forbidden nets to catch the endangered totoaba bass inside a marine reserve in Mexico's Gulf of California.

The totoaba is a rare fish native to the Gulf that can measure up to 6 feet in length and weigh as much as 220 pounds. Fishing for totoaba has been banned by the Mexican government since 1975, but it continues to be hunted by poachers solely for its swim bladder, which is sold on the black market in China for more than \$20,000 per kilo.

When spotted by the Farley Mowat crew, the poachers began retrieving their nets as fast as they could, while others fled the scene immediately. The Farley Mowat tracked these boats, even while some of them tried to slow it down by maneuvering around the Sea Shepherd vessel.

Throughout the process, the Farley Mowat remained steadfast, following the poachers for about an hour until the Navy arrived. The poachers attempted to evade capture, giving up only when the Navy came at them with rifles drawn. No shots

were fired.

"Without Sea Shepherd, the poachers would continue to destroy their own environment," said Farley Mowat Captain Sebastien Fau.

The Farley Mowat and the M/V Sam Simon are currently in the Gulf of California as part of Operation Milagro III to stop the imminent extinction of the endangered vaquita porpoise. Both ships are protecting the vaquita refuge and patrolling for poachers among other duties.

Known as the world's smallest and rarest marine mammal, the vaquita is facing a real threat of extinction. The most recent statistics show the population has dwindled to an estimated less than 60 individuals.

The biggest threat to the vaquita survival are the poachers using illegal gill nets to catch the totoaba. Vaquita often become entangled in the nets and are unable to reach the surface of the water to breathe, causing them to drown.

The arrested poachers were using shrimp nets – forbidden in the vaquita reserve since 2015 – and totoaba nets, which are banned in Mexico.

While investigating the nets left by the fleeing fishermen, Farley Mowat found such live animals as sharks, rays, crabs and other fish trapped in the mesh. All were released.

"Sea Shepherd's partnership with the Mexican Navy is achieving results," said Sea Shepherd founder and CEO Captain Paul Watson. "Every poaching vessel intercepted and arrested is one step closer to

preventing the extinction of the vaquita."

Said Campaign Leader and Director of Ship Operations, Captain Oona Layolle: "Our collaboration with the Mexican authorities in patrolling the area and retrieving nets is highly important to the safety of the vaquita refuge and marine reserve. The more boats Sea Shepherd has in the area, the better we can guard against poaching. The vaquita needs all of our efforts now."

# Potential State Record Rocky Mountain Bighorn Sheep Taken

Randy Spray has been putting in for a bighorn tag for 43 years and had never drawn one. He told a friend, "I really need to draw a tag, I'm getting older and pretty soon I won't be able to do a bighorn hunt." That friend suggested that Randy try putting in for Rocky Mountain bighorn instead of Desert Bighorn, and that did the trick. He was already in the max bonus point pool, and this year he finally drew his tag for the archery hunt in 6A.

Shooting the ram was not a problem. Spray is an avid tournament archer with two golds in the Senior Olympics, and a ton of other archery titles as well. He started scouting almost three months before the hunt, and had zeroed in on an incredibly rugged area near Camp Verde in

the Clear Creek Canyon.

The night before the hunt, his buddy glassed the ram, and in the morning they hiked about a mile down to him. But the sheep had moved, and when they found the herd, an ewe got between Spray and the ram and he couldn't shoot. The ram walked off and my friend thought it was all over, but then the ram came back and he made a perfect shot. "The ram slid about forty yards, to within ten feet of going over a 100+ foot cliff."

The Arizona Game and Fish have green scored the ram at 183 2/8 net. After the horns dry for 60 days it will be re-scored. The current state record of 176 4/8 is shared by two hunters, both of whom also shot their rams in 6A. A friend of his, a measurer for Pope and Young, scored Spray's ram at 181 net.

thanks to social media and immediate cooperation of the hunter, we were able to confirm that this deer was in fact taken in a completely ethical and legal manner."

Initially, a concerned citizen had sent the photo to Operation Game Thief. The majority of our state's hunters do the right thing and uphold the game laws in Arizona — this case is another example.

## Wolf Pup Introduced Into Foster Pack Gives Birth To Wild-Born Young

Biologists with the Mexican Wolf Interagency Field Team (IFT) recently learned a fostered wolf pup introduced to a pack in 2014 has produced a wild offspring of her own.

In a critical breakthrough in Mexican wolf management, the U.S. Fish and Wildlife Service recently reported that a genetic test of male 1561 revealed that it is the offspring of male 1293 and female 1346. The female was one of two pups fostered into the den of the Dark Canyon Pack in New Mexico in 2014.

"We now have proof that a fostered pup not only survived to adulthood, but that it is reproducing and contributing genetically important young into the wild," said Jim DeVos, assistant director of wild-

life management for the Arizona Game and Fish Department. "This is fantastic news for the program and demonstrates that fostering Mexican wolves so they grow up wild is effective and provides a critical step forward for wolf recovery."

The Arizona Game and Fish Commission and department support this fostering technique that introduces very young pups from captivity and places them into a wild-born litter of the same age. The pups are then raised in the wild rather than captivity.

Critics of the commission's decision to restrict releases in Arizona solely to fostering pups argued that until these pups reproduce there would be no genetic rescue.

"One of the key challenges to recovery of the Mexican wolf is long-term genetic management given that all Mexican wolves alive today originated from a founder population of only seven animals," DeVos said. "This approach has been used in genetic management of other species but until this month was unproven for Mexican wolves," said DeVos.

The Mexican Wolf Reintroduction Project is a collaborative effort of the U.S. Fish and Wildlife Service, Arizona Game and Fish Department, White Mountain Apache Tribe, USDA Forest Service, USDA Animal and Plant Health Inspection Service – Wildlife Services, and several participating counties in Arizona.

## Endangered Red Squirrel Population Decreases By 11

An annual survey of the Mount Graham red squirrel recently revealed a slight decline in the number of the endangered squirrels in the Pinaleno Mountains in southeastern Arizona.

The survey conducted jointly by the Arizona Game and Fish Department, Coronado National Forest, U.S. Fish and Wildlife Service and the University of Arizona estimated 252 squirrels. The survey is a decrease of 11 squirrels from the 2015 estimate of 263.

"While we'd prefer to see squirrel populations continually grow, it's not uncommon for them to fluctuate considerably from year to year," said Tim Snow, AZGFD terrestrial wildlife specialist. "At this point, we aren't immediately concerned with the lower squirrel numbers. We remain optimistic that our efforts are working to ensure the population has the best opportunity to flourish in the future."

The red squirrel survey is conducted each fall by visiting a random sample of known middens, which are areas where red squirrels store their pinecones. Mount Graham red squirrels live only in the upper elevation conifer forests of the Pinaleno Mountains and feed primarily on conifer seeds. Females produce two to seven young per year.

The species was declared endangered in 1987. The Mount Graham red squirrel population peaked at about 550 animals in the late 1990s, but typically ranges between 200 and 300 individuals.

Habitat losses caused by fire, insect infestations and poor cone crops caused by drought are considered primary factors influencing population size. Biologists continue to explore new methods to conserve the species, including squirrel research, habitat improvements and a pilot captive-breeding program.

Conservation of the species is guided by the Mount Graham Red Squirrel Recovery Team, a partnership that includes

## Photographed Jaguar Confirmed As 'New Visitor'

Scientists at the Arizona Game and Fish Department (AZGFD) completed an independent analysis of trail cam photos of a jaguar in the Huachuca Mountains and confirmed that the animal has not been seen previously in Arizona.

"Five scientists from the department independently examined the photos from the new sighting with those from previous jaguars in Arizona to compare spot patterns and concluded that this animal has not been sighted in previously in the state," said Jim DeVos, assistant director for Wildlife Management at AZGFD.

"While recognizing the importance of finding a new jaguar in Arizona, it is also important to point out that this animal, like all other jaguars observed in Arizona in at least 50 years, is a solitary male and



that the closest breeding population of this species is about 130 miles south of the International Border," added DeVos.

The other most recent sighting of a jaguar in Arizona was in the Santa Rita Mountains in southern Arizona; however, that animal has not been documented in the state since September 2015. Prior to

September 2015, this jaguar was photographed hundreds of times over a three-year period.

"Jaguars are a unique component of this state's wildlife diversity and it is exciting to document a new visitor. However, in the absence of female jaguars and with the irregularity with which we document any jaguar presence in Arizona, this sighting in early December is important, but not an indicator of an establishing population in the state," said DeVos.

## Relict Leopard Frogs Not In Need Of Federal Protection

*USFWS determines populations are stable or increasing thanks to proactive conservation efforts.*

A frog species in Arizona and southern Nevada does not need federal protection under the Endangered Species Act, thanks to the multi-partner conservation efforts of the Arizona Game and Fish Department, U.S. Fish and Wildlife Service, and other federal and state agencies that make up the Relict Leopard Frog Conservation Team. The Fish and Wildlife Service has determined that relict leopard frog populations are stable or increasing.

The Service was petitioned in 2002 by the Center for Biological Diversity and the Southern Utah Wilderness Alliance to list the relict leopard frog and designate critical habitat for it. The Service, Arizona Game and Fish and other partners were already involved in coordinated conservation efforts for the frog before the petition was filed. Those efforts include on-

going habitat management, establishment of new sites, and restoration activities, which have resulted in an overall reduction of most threats and an improvement in the species' status.

"This shows that collaborative, on-the-ground efforts lead to conservation successes," said Jim DeVos, assistant di-

rector for Game and Fish's Wildlife Management Division. "By taking proactive measures that preclude the need for listing a species under the Endangered Species Act, we have much more flexibility in actively managing the species so it can ultimately thrive."

Members of the Relict Leopard Frog Conservation Team have included the Arizona Game and Fish Department, U.S. Fish and Wildlife Service, Bureau of Land Management, National Park Service, Nevada Department of Wildlife, Utah Division of Wildlife Resources, Bureau of Reclamation, Environmental Protection Agency, Clark County (Nevada), the Southern Nevada Water Authority (including the Las Vegas Springs Preserve),

## Western Caucus Members Reject Obama's Massive 1.65 Million Acre Land Grabs

*Governor Doug Ducey's responding letter asks for respect for Arizona.*

WASHINGTON, D.C.— Last week, President Obama took unilateral action and issued a Presidential Proclamation under the outdated 1906 Antiquities Act, locking-up 1.35 million acres of land in southeastern Utah through designation of the new Bears Ears National Monument and locking-up 300,000 acres of land in Clark County, Nevada through designation of the new Gold Butte National Monument.

Congressional Western Caucus Chairman Paul A. Gosar, D.D.S. (AZ-04), Chairman Emeritus Rob Bishop (UT-01), Vice-Chairman for Policy Mark Amodei (NV-02), and Caucus Members Congressman Jason Chaffetz (UT-03), Congressman Chris Stewart (UT-02) and Congresswoman Mia Love (UT-04) issued the following statements in response:

### Responses From Gosar, Bishop, Amodei, Chaffetz, Stewart, Love

#### Gosar:

"Once again, President Obama has put the needs of special-interest groups like the Sierra Club, the Center for Biological Diversity and the Center for Western Priorities ahead of the needs of hard-working Americans," said Chairman Gosar. "No one man should be able to unilaterally lock-up millions of acres with the stroke of his pen, especially in the face of overwhelming local opposition. An overzealous, unaccountable bureaucracy operating in overdrive during its waning days is no way to govern.

"As Chairman of the Congressional Western Caucus, I will work with the Trump Administration to undo these land grabs and reform the outdated Antiquities Act in order to prevent this type of abuse from ever occurring again."

#### Bishop:

"Chairman Emeritus Rob Bishop released this video statement and stated, 'The announcement perpetuates two egregious lies. The first being that the size of the monument parallels the Public Lands Initiative. That is not true. The administration is grasping at arguments to justify a lame duck administration's efforts to do things contrary to the will of the people who live in San Juan County. The second lie is in the creation of a faux commission to give management authority to Native Americans.

"This is a diversion. The Utah delegation wants to give management authority to Native Americans; the administration can't. Only Congress can legally do so. This administration over promised, failed to deliver, and is now trying to hide its ineptitude."

#### Amodei:

"Hey Nevada — this sure as heck beats a transparent lands bill, doesn't it?" said Vice-Chairman Mark Amodei.

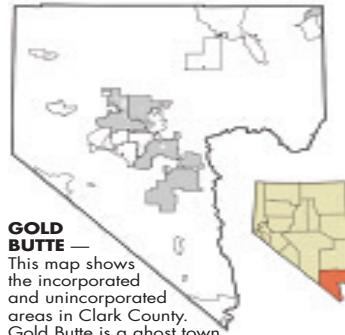
#### Chaffetz:

"This midnight monument is a slap in the face to the people of Utah, attempting to silence the voices of those who will bear the heavy burden it imposes. It does

not have the support of the Governor, a single member of the state's Congressional delegation, nor any local elected officials or state legislators who represent the area. We will work to repeal this top-down decision and replace it with one that garners local support and creates a balanced, win-win solution," said Congressman Jason Chaffetz.

#### Stewart:

"The creation of the Bears Ears National Monument marks the second time in the recent past that a president has used the Antiquities Act to lock up millions of acres of land in Utah without daring to set foot in the state. I am disgusted by the process and will fight this monument with every tool at my disposal, including through the appropriations process," said Congressman Chris Stewart.

#### Love:

"By unilaterally designating the Bears Ears area of San Juan County a National Monument, President Obama has undermined the economy and lifestyle of the people who live there, the religious interests of the Native Americans who reside in San Juan County, and ignored local authority. Again behaving more like a dictator instead of a representative of people, he ignored Utah, which is united in opposition to this action. I join our delegation, state officials and the people of Utah in the pledge to use every tool in our arsenal to undo what he has done, and restore the blessings of freedom he wants so badly to remove from us in his final days," said Congresswoman Mia Love.

### Background

With designation of the 1.35 million acre Bears Ears National Monument in Utah and the 300,000 acre Gold Butte National Monument in Nevada, President Obama has designated or expanded 29 national monuments, more than any other president in history. These unilateral proclamations have locked-up more than 550 million acres of land and water.

### No Significant Local Support

There is no significant local support for the Bears Ears designation as the locally elected county leaders, state legislators, governor, and federal delegation are all united in opposition to this monument. In addition, Commissioner Rebecca Benally, the only Navajo who holds elected office in Utah, recently appeared before the Natural Resources Committee to testify in opposition to the monument.

### A Viable Alternative

A viable legislative alternative available in HR. 5780, the Public Lands Initiative, passed the House Committee on Natural Resources in September of this year.

Congressman Chris Stewart passed an amendment through the House of Representatives to block the Bears Ears National Monument, the Gold Butte National Monument and other proposed monuments where there is significant local opposition earlier this year.

Senate Western Caucus Member Mike Lee recently authored an op-ed detailing why President Obama shouldn't unilaterally declare a Bears Ears National Monument.

Congressional Western Caucus Chairman Paul Gosar and several Caucus Members introduced H.R. 3946, the Protecting Local Communities from Executive Overreach Act, in order to prevent this type of abuse and require concurrence from local stakeholders in order to ensure a transparent process that involves the American people. This bill also would have blocked the Gold Butte National Monument in Clark County, Nevada.

The 1906 Antiquities Act stipulates that presidents can only declare monuments where "the smallest area compatible with the proper care and management of the objects" is protected. Locking-up more than 550 million acres hardly seems to fit this description.

### Negative Impacts

National monument designations under the Antiquities Act typically have significant consequences that negatively affect grazing rights, water rights, wildfire prevention and other land management activities. These declarations also result in some of the most restrictive land-use regulations possible and also greatly impact hunting, fishing, OHV and other recreational activities.

Unilateral designations that circumvent Congress typically result in devastating consequences for rural America. These land grabs kill jobs and limit future economic prosperity. Such actions also exacerbate challenges for local communities to fund services like education and infrastructure as lands that are added to the federal rolls can no longer be taxed.

### Arizona Governor Doug Ducey Responds

PHOENIX — In response to President Obama's designating two national monuments this week in Utah and Nevada, Governor Doug Ducey issued the following statement requesting that the president respect Arizona by not designating the proposed Grand Canyon Watershed

### National Monument:

"Western public land agreements have established a legacy of multi-use that have provided a recreational, environmental, conservation and economic balance that has served our state and nation well.

"In the early 1990s Republican Senator John McCain and Democratic Congressman Morris Udall worked appropriately through congressional action to create a massive footprint of designated wilderness in our state. Arizona also already hosts the most national monuments of any state in the nation. Those monuments more than suffice for enough acreage set aside for elevated public lands management. That work is now complete.

### Arizona Needs No Further Designations

"Our state needs no further designations. Designations done by decree have already negatively impacted our state's ability to manage wildlife, held in trust for the people of Arizona and our nation. Proof of this fact is seen in the decline of desert sheep in the Sonoran Desert Monument, where access closures impeded our ability to maintain water catchments to grow these herds.

"Forest management also suffers in special designation areas, and my fear with the proposed designation is a catastrophic fire that would damage this area for more than a century.

"I have long joined Senators McCain and Flake, the majority of our congressional delegation, more than 20 sportsmen/women organizations, the Arizona Game and Fish Commission, and thousands of Arizona citizens in steadfast opposition to this unneeded and poorly thought-out presidential decree that will permanently damage the recreational, environmental, conservation and economic balance that is so important to our state.

### Requests Respect

"I request that the president respect the wishes of our state's leadership and the Congress of the United States, which is where the real authority for public lands designations resides. The intent of the Antiquities Act gives the president limited authority to set aside the smallest amount of land possible to protect the artifact; this proposed designation of 1.9 million acres of land would be a clear violation of that intent.

"If designated by the president in his waning hours, Arizona will take every step necessary — legally and legislatively — to stop it. My hope is that the president respects our wishes."

*Note: The Arizona Game and Fish Commission opposes establishment of this unneeded national monument in Arizona ... [and] the loss of multiple-use public lands due to special land-use designations.*

## Are You Up To The Challenge?

Back by popular demand, Maricopa County's Parks and Recreation Department last month rolled out the 100 Miles in 100 Days Challenge.

"This is the sixth year Parks has offered the 100 Miles in 100 Days Challenge. Visitors love it because it's open to all abilities and user groups — hikers, trail runners, mountain bikers and horseback riders. It's also a great motivator for those looking to transition their indoor exercise routines back outdoors," stated Maricopa County Board of Supervisor Steve Gallardo, District 5.

While the Challenge initially started out as a Centennial celebration, it has become an annual program due to popularity. The goal of the program is to log 100 miles in 100 days. Last year, 33 of the 247 individuals who completed the Challenge logged at least 200 miles. And, if that wasn't impressive enough, two of the individuals managed to surpass 600 miles — each!

Collectively, those who completed the Challenge logged 34,936 miles on our County trails. That's 13,697 more miles than the team hiked the previous year, and to put things into perspective, just shy of traveling one-and-a-half times around the circumference of the Earth.

"The Challenge kicks-off on Nov. 1 each year. However, eager participants were already stopping by early at the nature centers to see if they could start. While this is amusing to us because the trails are open year-round, we understand that it's a personal challenge for park visitors and has become a badge of honor to those who complete it," said R.J. Cardin, Maricopa County Parks and Recreation Department director.

Knowing that it can be somewhat difficult to stay motivated during the holiday season, the department offers a community page on Facebook. Here, participants can share milestones, seek out trail recommendations, post photos, and join in on fun activities. The page is managed by the department's interpretive rangers who have also developed fitness hikes to help Challenge participants reach their program and personal goals.

"We offer a passport program during the Challenge at Estrella Mountain Regional Park. Every week, we explore a new part of the park, starting off with the easier trails and working our way up to the more difficult ones. It's a great way to meet new hiker friends, watch your fitness level grow, and take in Estrella's breathtaking landscape. And, the icing on the cake is we get to have a celebration when we're done with the Challenge," added Ranger Tippy Jackson, Estrella Mountain Regional Park.

Participating in the Challenge is simple; rules and trail guides may be obtained by visiting a County park or downloading a brochure at [www.maricopacountyparks.net](http://www.maricopacountyparks.net). Once participants have completed their trek, trail logs and entry forms may be returned to a County park to be eligible for a grand prize drawing of an annual park pass (\$85 value) and \$25 Nature Center retail voucher (total value not to exceed \$110).

## Fatal OHV Accidents Serve As Reminders To Practice Safety

The Arizona Game and Fish Department reminds all off-highway vehicle (OHV) drivers and passengers to wear the proper safety gear and ride responsibly in the wake of multiple separate accidents.

Since Thanksgiving, three people have died in accidents on OHVs. The first occurred in Mohave County after an ATV rolled, killing an 11-year-old female passenger and injuring the 12-year-old driver, according to the Mohave County Sheriff's Office.

The second accident claimed the life of a veteran Phoenix Fire captain who rolled the side-by-side he was driving while on an elk hunt south of the Grand Canyon, according to the Coconino County Sheriff's Office. Over the weekend, an 18-year-old Arizona State University student died after his ATV collided with a tree.

"It only takes a split-second for tragedy to strike," said Josh Hurst, AZGFD Off-Highway Vehicle Program coordinator. "The last few weeks have shown us that OHV accidents can happen to anybody at any time and that is why all riders and their passengers should wear the proper safety equipment at all times. Helmets save lives."

Riders and operators are reminded that helmets are required by law for all riders under the age of 18 regardless of the off-highway vehicle type. However, they are strongly recommended for all riders. In addition riders should remember to heed the following:

- Wear a seat belt at all times, if equipped.
- Only carry the number of passengers recommended by the manufacturer



for your vehicle. Often many accidents are the result of too many people riding a machine that was designed for fewer passengers.

- Wear riding goggles, a long-sleeved shirt, pants, riding gloves and over-the-ankle boots.
- Never ride alone.
- Be prepared and equipped with a map, a first aid kit, whistle and have basic tools on hand.
- Stay on designated trails.
- Take an OHV safety education course designed to teach off-road motorists how to ride safely and responsibly.

### Six Items All Riders Need

Another year has passed and if a new

off-highway vehicle (OHV) was in the cards this holiday season, the Arizona Game and Fish Department advises you to remember the wear the following equipment.

**1. A helmet.** Whether riding in a side-by-side utility-type vehicle (UTV), all-terrain vehicle (ATV) or dirt bike, all riders younger than 18 years old are legally required to wear a Department of Transportation-approved helmet. Helmets are strongly recommended for all riders older than 18.

**2. Eye protection,** such as riding goggles, is legally required for all riders if the OHV is not equipped with a windshield.

**3. Riding gloves** should be worn at all times to protect your hands while riding and enhance your grip while driving.

**4. Wear proper clothing,** including a long-sleeve shirt, pants and over-the-

ankle boots.

**5. Register your OHV** and purchase an OHV Decal. All vehicles designed primarily for travel on unimproved terrain and weighing less than 1,800 pounds are required to have a \$25 OHV decal to operate on public and state lands. License plates and decals are available at any Arizona Motor Vehicle Division location or at [www.servicearizona.com](http://www.servicearizona.com).

**6. Take a safety course.** Safety courses teach new and veteran riders the techniques needed to safely operate and ride an OHV, including the importance of shifting their weight, maintaining control of the machine, evasive breaking and maneuvers. For information on where to take a course or to take one online, visit [www.azgfd.com/Education/OHV](http://www.azgfd.com/Education/OHV).

Always remember to supervise children under 16 years old and check to ensure your child is riding an age-appropriate vehicle. Machines may be too large and powerful for a child to safely operate. Parents are ultimately responsible for their children's safety.

Riders should only carry the number of passengers for which the machine is designed. One of the biggest causes of OHV-related injuries is riding with more than the recommended number of passengers. Proper riding techniques require operators to shift their weight and change position to keep control of the machine. Carrying a passenger can make riding difficult and change how the vehicle responds.

## International College Students To Revive Lonely Dell Orchard

On Jan. 10, more than 200 college students representing 13 countries will revitalize one of the most important historic sites on the Colorado River as part of an education and service-based collaboration between the U.S. Department of State's Community College Initiative Program and the National Park Service.

### International Exchange Program

The U.S. Department of State's CCI Program is an international exchange program, administered by Northern Virginia Community College on behalf of the Community College Consortium, that provides participants with a one-year, non-degree academic program in workforce development fields at a U.S. community college. The CCI Program recruits participants from underserved and unrepresented communities, particularly women. Since 2007, the CCI Program has hosted more than 2,800 participants from 21 countries.

### Students To Revive Historic Orchard

To celebrate the Community College Initiative Program's ten-year anniversary, and commemorate 100 years of the U.S. National Park Service, this year's 211 students and 22 staff will work together in Glen Canyon National Recreation Area to revive a historic orchard as a service learning event. The theme of the event is "Sowing Seeds of Good Intentions for the Future."

The historic orchard is located at Lonely Dell Ranch in the Lees Ferry Historic District, which is an integral part of the history of the earliest Euro-Americans settling along the Colorado River. Lees Ferry was established in the 1872 as the only viable crossing of the Colorado River for hundreds of miles.

### Lonely Dell Used Until 1928

Lees Ferry was used by early members of the Church of Jesus Christ of Latter-Day Saints and other pioneers until 1928. A homestead at the mouth of the Paria Canyon, called Lonely Dell, still stands as a testament to the lives of ferry operators and their families. The Lonely Dell orchard is watered by irrigation systems that were established in the 1880s, and is maintained by the National Park Service as part of the cultural landscape that contributes to the experience of history that people receive when visiting the Lees Ferry Historic District.

Today, the orchard at Lonely Dell continues to bear fruit and provide shade for visitors to Glen Canyon National Recreation Area. The orchard stands in stark contrast to the harsh desert landscape and reminds visitors what is possible when groups of people work together to seek creative solutions to life's challenging problems. The participants in the Community College Initiative Program will plant new trees in the orchard to replace trees that have died, prune and maintain healthy trees, and work on irrigation systems from three different historic time periods to keep the orchard green and lush for future visitors, many of whom are direct descendants of the original pioneers who established Lonely Dell.

This year alone visitation has increased by 7.5% with help from national campaigns like "Find Your Park", a social media public campaign to raise awareness of the NPS Centennial. Since its establishment in 1919, Grand Canyon National Park has received more than 200 million visitors.

Celebrating the 6 millionth visitor is a significant milestone that all park staff and community are proud of. As the NPS Centennial year comes to an end, the Grand Canyon team is looking forward to its own centennial celebration in 2019 when it will continue to inspire future generations to be stewards of public lands.

### Find Your Park Helps Grand Canyon

In 2015 visitation to Grand Canyon National Park increased by almost 1 million visitors, and this centennial year visitation continues to increase by 8.6 percent, amounting to more than 6 million visitors. This is an exciting landmark for Grand Canyon National Park which has seen a steady increase in visitation since 2011 and, since its establishment as a national park has received more than 200 million visitors.

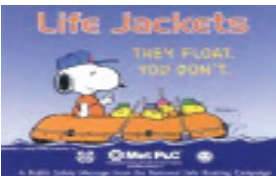

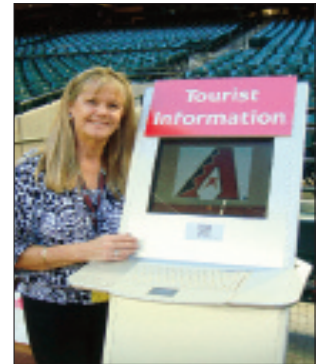

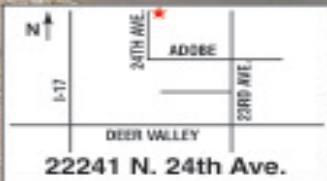
