Heading North Is An Excellent Summer Plan!

This Is The Perfect Time

Summer is the perfect time to visit the North Rim of the Grand Canyon because the higher elevation of the North Rim means forest and cool summer days. The North Rim is usually a lot less crowded than the South Rim as well, mostly because it takes a lot longer to get there. We took a five-day trip in June that in-

We took a five-day trip in June that included Page, Marble Canyon, Lee's Ferry, and the North Rim, and it was awesome. Granted, the weather was a bit hot in Page and Marble Canyon, but not quite as hot as in the Valley, so we had a great time.

Here are some things to do if you decide to head up there as well. Be aware that although Page and Marble Canyon will be cooler in the winter, the North Rim has seasonal closings.

The North Rim Season

Here's what the National Park Service has to say about winter at the North Rim: The full season is May 15 - October 15 and the last day for lodging, restaurants, and ranger programs is October 15. The "shoulder" season starts October 16, meaning that the Visitor Center, bookstore, and backcountry permit office are open through October 31.

During November, the North Rim is open dawn to dusk only – no overnight parking, unless snow closes highway 67 before the end of the November. Gas and diesel are available, pay at the pump, during November. Once the AZDOT closes highway 67 south of Jacob Lake (usually by December 1), the North Rim also closes to vehicle traffic. There will be a locked gate at Jacob Lake and the gate at the North Rim entrance as well and they won't open until mid-May. If you plan to visit later in the year, check

If you plan to visit later in the year, check the Arizona Department of Transportation website for road closure info.

First Stop: Page

Our first stop was Page, about a 6-1/2 hour drive from Phoenix with a breakfast stop in Flagstaff. In Page, we took a tour of the Glen Canyon Dam, which was a lot of fun, then we drove over the border into Utah and went to Lone Rock, a great beach on Lake Powell that is named after the enormous, almost-vertical, block of stone that emerges from the middle of the lake.

Wahweap

The water is a gorgeous pale turquoise here that is impossible to capture with a camera, and the swimming is great. You can drive very close to the beach and there is plenty of sand and sun. After we left this beach, we drove back to Arizona to visit Wahweap for a little more swimming. There is a \$30 entry fee to Lake Powell/Glen Canyon National Recreation Area, but our senior pass got us in free.

When we bought ours it was \$10, and it's now \$90, but it is good for your lifetime. If you are 62 or older, go to https://store.usgs. gov/senior-pass for information on how to get one. It will also save you the \$25 entry fee to the Grand Canyon.

At Wahweap, we parked in the picnic area and had a hike to the beach, where there is no shade. It was quite a walk, and by the time we got back to the car, we were all hot and sweaty again. TIP: bring water shoes! Don't attempt to do the walks in flip flops or sandals, and don't go in the lake without shoes. The hot sand goes right over sandals, and you never know if there is something sharp in the water. Better safe than sorry.

On To Marble Canyon

On the drive to Marble Canyon, we took the hike out to Horseshoe Bend, which is just south of Page on Highway 89. You can't

miss the big parking lot on the west side of the highway. The hike is longer than you might think: about $\frac{3}{4}$ of a mile, and you definitely need to bring water. It was really hot already, and we got out there by 8 a.m.

The hike is so worth it, though – it's a gorgeous spot. There are no guard rails at all, so keep a sharp eye on kids and keep a leash on any pet. This is a free site.

Our next stay was at Marble Canyon Lodge for a couple of nights. This is a great place, especially because you can get a nice cabin with two bedrooms and a full kitchen. However, the cooling is only a swamp

Storm Safety Tips

The best thing to do during monsoon season is to stay home if storms are forecast for the day you're planning to go out on the water. But if you find yourself out on the lake when a storm hits, there are key steps to take to stay safe.

Wear your life jacket (They're required for children 12 and younger.)



Monitor the weather around you And use a weather radio for updates from the National Weather Service.

3

Secure your gear Secure all gear above and below decks.



Keep everyone onboard away from electrical and ungrounded components, and remain as low in the boat as possible.



Slow down



Safe harbor

If possible, head for the nearest shore that's safe to approach. It may be best to ride it out in open water rather than try to approach the shore in heavy wind and waves.

2 Head into the waves

Boats should head the bow into the waves at a 45-degree angle. Personal watercrafts should head directly into the waves.

Five Mistakes That Can Cost Boaters

Here are some lessons learned from cases taken out of the BoatUS Consumer Protection Dispute Resolution Program files.

For the past 28 years, the Boat Owners Association of The United States (BoatUS) Consumer Protection Dispute Resolution Program has gone to bat thousands of times for BoatUS members seeking help after disputes arise with boat purchases, repairs, or other service issues. This free service offered to BoatUS members often gets successful resolutions for these types of consumer issues.

Here are some mistakes BoatUS has identified that can help any boat owner avoid a dispute with a service provider or with a boat purchase this summer.

1. Not using a purchase contract: When a BoatUS member found out that a battery and other equipment had been removed from the sailboat he had purchased, he called BoatUS Consumer Protection. Unfortunately, the member did not have a purchase contract that spelled out the price, listed included equipment, and was signed by both parties. This was an expensive lesson because the battery and other equipment accounted for about half of the purchase price of the boat.

2. Not sea-trialing the boat after repairs are made: A BoatUS member purchased a used powerboat that was found to have a cracked engine head. The sales contract said the engine had to be working, so repairs were made and the dealer verified with a compression test to ensure everything was fine. It wasn't. After the purchaser paid for the boat, the engine promptly blew a hole in the side of the block. The dealer balked at offering a used engine replacement because the contract stated "as-is" condition. Lesson: Don't accept the boat until all repairs have been made and verified with a sea-trial, and be sure to spell out contingencies in the contract

3. Not allowing a shop to attempt to honor its warranty: After a BoatUS member's inboard engine quit on a Memorial Day trip, he decided to seek out a repair shop on Craigslist in order to get back on the water as quickly as possible. After he got the boat back from a shop he'd found, the engine was still not working, so the member lost confidence and took it to another shop to fix it, which it did satisfactorily. But, when the member went back to the first shop to seek warranty reimbursement, it refused. Lesson: Warranty law allows a shop to be given the opportunity to correct the problem. Don't expect a shop to give up this right, even if you are in a hurry.

4. Not verifying the paperwork was sent: A BoatUS member bought a ski boat with several years remaining on a 5-year manufacturer warranty that the seller said transferred with the boat. Shortly thereafter, the boat had a catastrophic engine failure due to a failed pump. Unfortunately, the seller neglected to transfer the warranty to the member, and the \$10,000 engine replacement was not covered. Lesson: Some warranties have specific transfer procedures that must be followed, including paying a fee, paperwork that must be signed and delivered, and sometimes even a maintenance check by a qualified shop. Add a sales contingency to the sales

contract that addresses the successful transfer of the original warranty

5. Not letting the shop be involved in the diagnosis: When a small diesel engine was having starting issues, a repair shop told a BoatUS member that water was found in the cylinders. Instead of allowing the shop to investigate further and fix the engine, the member bought a new engine to have the shop install. However, the new engine was just the block, so the shop had to install the old starter, alternator and intake and exhaust manifolds to complete the job. After installation, water was soon found in the new engine's cylinders. The shop advised the member the warranty was only on the new base engine, and not the old manifolds that leaked in the engine. Lesson: By telling a shop that the engine simply has starting issues, for example, a successful fix by the shop will come with a warranty on the work. However, telling the shop what parts to replace implies no warranty to the initial problem – the shop is just following your orders. For major work especially, let the shop do their job and recommend the repair.



BoatUS offers on-water Unlimited Towing Memberships for freshwater boaters and anglers for just \$72 per year. Boaters without BoatUS towing services face costs that average \$750 per towing incident, with some paying into the thousands out of pocket.

Know The River

With a mix of both new and seasoned

boaters on this section of the Colorado River, Wilde is prepared to see the abundance of on-water activity this summer. However, he offered that even the most experienced of boaters sometimes run into issues on this waterway. "You really have to know the river this time of year," he said. "There are a lot of rock bars, and the farther north you get toward Davis Dam, the quicker and more often the water fluctuates. If you don't pay attention to the water release levels, you can easily get caught and hit bottom."

Common Goal

Wilde, who is U.S. Coast Guard licensed, also maintains an excellent relationship with local law enforcement. "We have a great working relationship with a common goal to help get boaters home safely," explained Wilde.

TowBoatUS Needles operates a 21foot center-console response boat with

Three Mistakes Boaters Don't Want To Make With A DSC-VHF

For recreational boaters, sailors and anglers, having a Digital Selective Calling (DSC) VHF radio aboard to call for emergency help will always be the fastest way to summon assistance from your closest rescuers. That means that going without one can hurt your chances for a safe summer on the water. Here are three common mistakes boat owners make with DSC-VHF radios and some simple ways to improve safety aboard your boat.

Mistake #1: Relying on an old VHF radio to signal that you are in distress — If you are using a VHF radio that was manufactured more than 15 years ago, you're relying on old technology. There's probably not a person around that regularly uses a 15-year-old phone, television set or computer. Today's DSC-VHF ra-

Eight Tips For Boating Safely During Storms

During monsoon season, AZGFD reminds boaters to use caution.

During monsoon season, the Arizona Game and Fish Department (AZGFD) wants to remind boaters about how they should react during a storm. When out on the water, weather conditions can change quickly and could be dangerous for unprepared boaters.

"While the skies may look sunny as you're heading to the lake, it's important to always check the weather forecast for the entirety of the trip," said Josh Hoffman, AZGFD's boating safety education coordinator.

"If severe weather is likely, stay home and reschedule your trip for another day. And if you're already on the lake or river and storms are starting nearby, get off the water if you can do so safely.

AZGFD offers the following eight tips for boaters to protect themselves and their passengers during a storm:

1. Life Jackets: While life jackets are required for children 12 and younger, everyone should wear a life jacket at all times while on the water. Storms can create large waves that could knock a passenger from the boat.

2. Weather: Monitor the weather around you, and use a weather radio for updates from the National Weather Service. If storms are predicted or are building, pull your boat out of the water or consider postponing your outing.

3. Gear: Secure all gear above and below decks.

4. **Position:** Keep everyone onboard away from electrical and ungrounded components, and remain as low in the boat as possible.

5. Slower Speed:Slow down but keep

enough power to maintain headway and steering. 6. Lights: Turn on your navigation

7. Location: If possible, head for the

nearest shore that's safe to approach. It may be best to ride it out in open water rather than try to approach the shore in heavy wind and waves

8. Headings: Boats should head the bow into the waves at a 45-degree angle. Personal watercrafts should head directly into the waves.

'Thinking through these actions in advance can help prepare you in the event that you find yourself on the water when a storm hits," Hoffman said.

"It's also a good idea to leave a float plan with a friend or relative who isn't going on the boat with you. Be sure to in-



clude where you're going and when you expect to return so they can follow up to make sure you made it home safely.

AZGFD offers free boater education courses that cover instruction on the basic skills required to safely operate a boat or personal watercraft, navigational rules, legal requirements and boating emergencies. The classes take place monthly in Phoenix and Lake Havasu City and are a great source of information for both new and veteran boaters. AZGFD Gets Help In Fight Against Invasive Mussels MUSSEL

The U.S. Bureau of Reclamation has allocated more than \$4 million to support existing work by western states and tribes to combat the spread of invasive quagga and zebra mussels. Arizona has several quagga mussel-infested waterbodies and will benefit from the increased funding.

The allocation is part of an initiative by Department of Interior Secretary Zinke called, "Safeguarding the West: Actions to Strengthen Federal, State, and Tribal Coordination to Address Invasive Mussels

Arizona Was First

Arizona was among the first western states to have an introduction of the invasive mussels following their 2007 discovery in Lake Mead.

"This money will be a tremendous help to our program," said Erin Raney, AZGFD Aquatic Invasive Species Coordinator. "Containing the spread of invasive mussels is costly, but worthwhile in the long run. We just haven't had the resources to properly address the issue in Arizona before now.

single engine outboards ready 24/7 to service boaters between the I-40 bridge at Topock, north to Davis Dam. The company also keeps a 19-foot center-console as backup in case of high demand. dios have new lifesaving features, most importantly a distress button that can hail a mayday and relay your position to rescue authorities - all at the push of one little red (distress) button on the face of the radio. BoatUS has some help to set up your new DSC-VHF radio at BoatUS.com/SettingUpDSCRadio.

Mistake #2: Thinking you don't need to bother to register a DSC-VHF and get an MMSI number - A Maritime Mobile Service Identity (MMSI) number is a unique registration number that is assigned to your vessel to be used with the vessel's DSC-VHF radio. MMSI numbers are issued by organizations including BoatUS which offer the service at no cost to members or for a nominal \$25 fee for non-members

The MMSI must be entered into the radio in order to harness all of its power and lifesaving technology. Registering your radio gives potential rescuers important information about you, your boat and whom to contact in an emergency

Mistake #3: Not reading the owner's manual that came with your radio and familiarizing yourself with your radio's features — Your DSC-VHF radio manual contains a ton of great information about the features of your radio and how to install it. If your radio is not properly installed or not connected to your boat's GPS or chartplotter, you're shortchanging yourself and perhaps unknowingly putting yourself and your crew in danger if there is a delay in transmission and emergency response

ation opportunities."

Working Together

Money allocated to Arizona will be used to support existing and future efforts to increase watercraft inspections and decontamination locations throughout the state and to bolster enforcement efforts. Watercraft inspections and decontaminations reduce the risk of spreading quagga mussels and other aquatic invasive species (AIS). Having a seal and receipt documenting a certified inspection can help decrease wait times at inspection locations, and reduce the risk of costly citations or impoundment of watercraft for transporting AIS

We are already working with local, state, interstate and federal partners, as well as private industry to build our program and provide more inspection and decontamination opportunities for boaters," Raney said. "We hope that by expanding services, we will get better compliance. It's a big job, but with everybody pitching in, we can stop their spread.

Digital Selective Calling technology can also make your everyday boating better. In addition to being able to send a distress signal with the press of a button, a DSC-VHF radio can privately hail other DSC-VHF-equipped vessels or groups of boats without tying up VHF channel 16, the distress, safety and calling frequency. It also allows you to 'ring' (hail) others if you know their MMSI numbers without them having to monitor a particular channel.

If you haven't yet purchased a DSC-VHF radio, make it one of your safetygear equipment priorities this season. To learn more DSC-VHF radios, take a free online DSC-VHF radio tutorial at www. AZGFD To Address Water Quality Issues At Luna Lake

Long-term project could include four White Mountains waters.

The Arizona Game and Fish Department (AZGFD) is collaborating with the White Mountain Lakes Foundation and the Apache-Sitgreaves National Forest to address chronic and long-term waterquality issues at Luna Lake near Alpine.

The ongoing project could eventually include other lakes located on the national forest: Carnero Lake, Lee Valley Lake and Crescent Lake.

Luna Lake First

AZGFD plans to install the first aeration system at Luna Lake during the spring of 2019. If the concept and approach prove successful at Luna, funding for installation of aerators at the other three lakes will be pursued.

"Once started, installation of the aeration system at Luna should be finished in only a few months," said Dave Weedman, AZGFD Aquatic Habitat Program Manager. "Luna Lake is the most cost-effective option because it is more easily accessible during the winter for maintenance than the other three lakes, and we have numerous partners in the area that will assist in the maintenance and upkeep of the facility."



Spring Hunt Recommendations Available For Review

The Arizona Game and Fish Department's proposed recommendations for the 2019 spring javelina, bison and bear hunts, and 2019 and 2020 spring turkey hunts are available for review at www.azgfd.gov/ huntguidelines.

The hunt structures and recommendations were formulated based on the hunt guidelines approved by the Arizona Game and Fish Commission in September 2017. All questions or comments about

All questions or comments about a particular game management unit or hunt are welcome by emailing at AZHuntGuidelines@azgfd.gov, or by calling any of the department's statewide regional offices and asking to speak to a game management biologist. No formal presentations are planned.

The proposed hunt recommendations will be presented to the Commission for its consideration during a public meeting Aug. 3 at Little America Hotel, 2515 E. Butler Ave., Flagstaff, 86004.

Begins Immediately

Successful project implementation will require collaboration between the AZGFD and Alpine Ranger District on the environmental compliance (NEPA) for beginning construction on the infrastructure. Both agencies have committed to begin the NEPA process immediately.

Identifying Problem

AZGFD biologists are monitoring water quality at all four lakes in an attempt to identify the causes for the water quality problems. Each of these lakes has periodically suffered from winter or summer fish die-offs as a result of poor water quality, low dissolved oxygen (DO) in the winter or excessively high pH in the summer.

AZGFD has already solicited plans for installation of aerators to address low oxygen during the winters, and is pursuing the needed environmental clearances to pave the way for installation and operation of the equipment.

Each of these lakes is different and will require a multi-faceted approach to address the water quality causes for the fish die-offs.

For Example

Crescent Lake receives an elevated level of nutrients from the watershed that contributes to excessive plant and algae growth. During the winter, as the lake ices over, transfer of oxygen from the air to the water is cut off, as is production of oxygen through photosynthesis by the plants and algae, while decomposing plant matter under the ice burns up all the oxygen, leaving none to keep fish alive. Aeration, in combination with nutrient control, may prove to resolve this issue.

Luna Lake suffers from a similar condition during the winter, as well as an elevated pH and low oxygen problem during the summer as excessive plant growth and blue-green algae absorb carbon dioxide, causing the pH to rise during the day. At night, when photosynthesis shuts down, the production of oxygen also shuts down. Respiration by zooplankton and decomposition by bacteria consume oxygen, causing a daily low DO condition that may stress and/or kill fish.

Sam Shattenberg Shares Spinnerbait Secrets

Sam Shattenberg has been fishing tournaments for over twenty-five years, has over 500 trophies, has made fifteen state teams, and has never lost money fishing tournaments. At a tournament at Roosevelt Lake when some teams were struggling to put together a limit at all, Sam and his partner came in with a limit of big fish. How does he do it? Mostly with blades.

Deciding Factor

"I believe that a certain percentage of fish will always be within eight to ten feet of the bank," says Sam, "so I always look there first." Sam fishes to be consistent, always looking to get a limit first, then go hunting for big fish later. Spinnerbaits have been the deciding factor in much of his fishing success. "Bass will relate to one of two things:

"Bass will relate to one of two things: structure or bait," explains Shattenberg, "so I fish structure on the bank and watch my graph for bait." At that Roosevelt tournament, Sam was about 100 to 150 feet from the bank, throwing spinnerbaits, when he noticed bait fish and bass on his X-70 at eight to twelve feet. He started throwing his spinnerbait in front of the boat, reeling as soon as it hit the water, but trying to keep the bait at about 8 feet deep.

That is how he and his partner caught all the big fish. They had already caught some fish over the slot, but the ones they found in open water were better.

Common Denominator

The one common denominator in Sam's spinnerbaits is red. He likes baits with a bit of red on the head, and he also puts some on the blades themselves. Sam carries a felt-tipped pen with indelible red ink, and he puts a "thumbnail-sized" red

dot on the backs of his spinnerbait blades. He is firmly convinced that this spot of red is responsible for a large percentage of his bites. "Every bait I ever throw has some red on it," Shattenberg declares, "crankbaits, spinnerbaits, worms, whatever. If it doesn't have red on it when I get it, I put some on."

Feeling The Vibes

Shattenberg says that when you fish a spinnerbait, you need to keep your rod pointed right at the lure, not off to the side or down, but right at the bait, as horizontal as you can make it. That way, he says, you feel everything the bait does. Your line isn't rubbing on the guides or pressing against the tip at an angle, and every vibration gets transmitted to your fingertips.

When you hold the rod off to the side or point it down at the water, Sm says, you aren't just robbing yourself of the right feel, you're taking away a lot of your hookset. When Sam gets a bite, he slams the rod up hard and never stops reeling. "Those first ten to twelve inches are what puts the barb through," he explains, "and if you are just pulling on the rod, that won't cut it."

Totally Concentrate

He holds the rod with his hand under the reel, keeping his finger and thumb loosely on the line just in front of the reel. "I don't squeeze the line," he emphasizes, "I just keep my finger and thumb on it lightly so I can really keep in contact with that bait. When you fish a spinnerbait, you have to totally concentrate on what that blade is doing."

Bump And Pull

Shattenberg doesn't believe in letting his line go slack while he's fishing a spinnerbait, so he uses what he calls a "bump and pull" retrieve. He starts reeling as soon as his lure hits the water, and keeps the line taut while he gets the lure to the depth he wants. When he bumps into something, he stops reeling, but pulls up on the rod, keeping the line from going slack but still changing the action of the spinnerbait. "If you're struggling on a slow-roll, that bump and pull can really make a difference," Sam declares, "and with smallmouth bass, it's sometimes just about the only way to really get them to bite."

The Strike Zona

"Good fish will usually be on a little crease or cut or something else you can figure out," Sam says, "and I believe the strike zone is all the area where you can get hung up, plus about five feet." When the water is dirty, he has found that the fish stay closer to the structure, and he tries to get his lure right in there to them.

Fishing For Smallmouth, Stripers Continues To Be Good

Quality of life is measured by amount of time spent fishing.

Lake Powell's water level is declining at the rate of about 1-foot per week. That will slow down slightly in September or level out if the monsoon season provides more inflow to counter that being released.

This decline will bring the lake level back down to near the five-year average of 3590-3600 feet (MSL). That means the Castle Rock Cut will remain open for those boaters launching at the south end of the lake and running upstream. We certainly hope that the winter of 2018 will provide more moisture to the parched southwestern area of the US and allow the lake to remain in this comfort zone.

Smallmouth Bass

Fishing continues to be good for smallmouth bass over the length of the lake. The hot spot this past week was the San Juan Arm. Bass there average a 1-2 pounds but they are super aggressive. If looking for a great family fishing trip the San Juan is a good choice.

Over the length of the lake, smallmouth bass fishing is consistent, with the best lures being green (crayfish colored) plastic grubs. A wide variety of lures, baits and techniques work well, with time of day being as important as which lures are used. Make sure to get out early and stay out late for the best bass fishing results. While jigging along the 12-25 foot bottom for bass, a few walleye, largemouth bass and catfish will join in the fun. Topwater action at first light in the morning is still the best bass fishing technique.

Striped Bass

Striped bass are boiling in the northern lake from The Horn (just upstream from Good Hope Bay) to Trachyte and White Canyon. Boils happen there because the shad crop is larger in size and numbers. It's a long run to launch at Halls or Bullfrog and run to Trachyte but the fish-

how do I learn to work on guns? (part 2) The Gunsmiths Address Firearms Disassembly

BY MIKE BERGER AND PAT KNIGHT

If you have an owner's manual for your firearm, this is an excellent place to start. Read the manual through several times before you pick up a tool. If there is a video available watch it. Does it follow the recommended process in the owner's manual? Does the person in the video appear to be competent? Are they using proper tools that are organized? Do they caution about the spring that they are about to release being under tension, or other safety concerns?

Assemble the proper tools; lay them out in a clean and safe work area that is free from distractions like TV. Pull up the video, have your instructions handy, and then go and get the firearm. In a safe location, check several times to insure that the firearm is completely empty. I cannot tell



you how often the words ..."but I thought it was empty..." have been spoken. Even an "empty" gun should never be pointed at anything you are not willing to destroy.

Work Slowly

When disassembling a firearm, work slowly. Have a clean uncluttered area to lay out parts. Small zip top plastic bags are an excellent way to keep sub-assemblies together and organized. Blue painters tape can be used to tag and keep track of small pins, springs and those pesky little detent balls. When working on more than one gun, such as when waiting for parts, boxes for each gun help to keep the parts separated.

We frequently use empty boxes from larger target-type scopes, as they will usually accommodate all of the smaller parts. Cell phone cameras can be used to photograph the way that parts look in a gun, so you can get them in there correctly during reassembly.

Cleaning Supplies

Cleaning supplies to have handy are spray-type cleaning chemicals (aerosol or pump), cotton swabs, tooth picks, pipe cleaners, new tooth brushes and isopropyl alcohol. While the gun is apart, this is an excellent time to detail clean, inspect and lubricate. All too often, people have a tendency to over lubricate their guns. The lubricant mixes with dust, dirt and powder residue forming a gummy film. This can cause problems all the way up to failures to fire or cycle.

failures to fire or cycle. It should be noted that WD-40, while an excellent product, is a (W)ater (D)isplacing liquid, and not a lubricant. It can have a negative effect on primers and gun powder, and should not be used as a firearm lubricant. It is, however, an excellent cleaner, particularly if a gun has been in the rain or otherwise exposed to water. A good cleaning with WD-40, and then a thorough drying and light lubrication with gun oil is a good way to stave off rust.



Commercial Unitized-Type Triggers

Be Careful With Oils

Do not let gun oils soak into the wood of the stock. Particularly not in the areas of inletting for metal parts. It will cause the fibers of the wood to break down and become spongy, eventually rotting. This is a good time to make sure that the hidden areas of the stock are adequately sealed from the possible introduction of any moisture. Changes in moisture in the wood can cause it to warp and have a very detrimental effect on accuracy (one of the reasons why we glass bed). You can seal the wood by rubbing in

You can seal the wood by rubbing in a light coating of wood finishing oil. Organic or mainly organic finish products

Five Reasons Why You Need A Concealed-Carry Permit

Arizona allows all of its citizens to legally carry a concealed weapon, but a CCW Permit is still a great idea for a lot of reasons. First and foremost is the training you receive when you attend a CCW class. I've been shooting all my life, but I learned a lot of new stuff when I attended a CCW class.

'Shoot Or Don't Shoot'

One thing that really opened my eyes was the "shoot/don't shoot" portion at the end of the class. I was handed a plastic pistol that interacts with a large screen, and a series of scenarios played out: an armed robbery in a jewelry store, a fight in a parking lot, a purse snatching, etc. Things happened fast, just as in real life, and I had to make decisions.

RV/Land Cruising Tourism To Grand Canyon National Park Creates Economic Benefits

Report shows visitor spending supports over 9,000 jobs in local economy.

A national park service report shows that more than 6.2 million recreational visitors to Grand Canyon National Park in 2017 spent \$667 million in communities near the park. That spending supported 9.423 jobs in the local area and had a cumulative benefit to the local economy of \$938 million.

"Grand Canyon is proud to welcome visitors from across the country and around the world," said Chris Lehnertz, Grand Canyon National Park superintendent. "National park tourism is a significant driver in the national economy, returning \$10 for every \$1 invested in the



National Park Service, and it is a big factor in our local economy as well."

The peer-reviewed visitor spending analysis was conducted by economists Catherine Cullinane Thomas of the U.S. Geological Survey and Lynne Koontz of the National Park Service. The report shows \$18.2 billion of direct spending by more than 330 million park visitors in communities within 60 miles of a national park. This spending supported 306,000 jobs nationally; 255,900 of those jobs are found in these gateway communities. The cumulative benefit to the U.S. economy was \$35.8 billion.

The lodging sector received the highest direct contributions with \$5.5 billion in economic output to local gateway economics and 49,000 jobs. The restaurants sector received the next greatest direct contributions with \$3.7 billion in economic output to local gateway economies and 60,500 jobs.

According to the 2017 report, most park visitor spending was for lodging/ camping (32.9 percent) followed by food

cooler, which would be unbearable during monsoon season. Also, there is a restaurant there and a gas station, but if you plan to cook your own meals, get groceries in Page because there is nothing at Marble Canyon but a small convenience store at the gas station.



Paria River Canyon: this is a fantastic hike that you find on the way to Lee's Ferry. Look for the sign saying "Lonely Dell".

Lee's Ferry And Beyond

We hiked down the Paria River Canyon the first evening, and it's gorgeous there's a big orchard there and old buildings from the original Lee's Ferry operators. The girls (our granddaughters) hiked in the Paria River and loved every minute. We went quite a way up the river, but you can actually get a permit and hike all the way through the canyon from Utah - takes three or four days.

The next evening we hiked a short trail past Lee's Ferry around sunset and saw a bighorn ewe and her baby. Marble Canyon is gorgeous – it's situated right in the middle of the Vermillion Cliffs, with Echo cliffs across the way, and the Grand Canyon (Lee's Ferry) just up the road.

Inside GCNP

We explored quite a bit of the Kaibab National Forest one day, and I'll tell you about that next time. Once we were inside the Grand Canyon National Park, we went first to the East Rim where there was

almost nobody else. The road in is gravel, but it's a good road and no problem for a car. The trail goes out to a gorgeous view of Saddle Mountain Wilderness and the forest there is beautiful.

Cape Royal Road

Next up was the Cape Royal Road, which has several gorgeous canyon viewpoints; we stopped at all of them. This road is a bit lower than the road to the lodge, so it was a little warmer. At times we were in junipers rather than pines. About a third of a mile before Cape Royal itself, watch for a small pull-out on the left

Cliff Springs

Across from it is a small sign that says Cliff Springs. This is a short hike down to some gorgeous cliffs with a spring coming right out of the wall. We shared the trail with a mule deer doe. You'll pass an old Indian granary on the way, and it's a gorgeous hike. It's uphill coming back, but it isn't bad, and it's totally worth it.

Widforss Trail

On the way to the lodge, where we had reservations for dinner as well as two cabins, we took a side trip up a dirt road that said Widforss Trail. On the right as you pass a meadow, keep an eye out for a small pullout on the left, and a little trail through the meadow on the right. The



This trail is picked up just past the parking lot at Lee's Ferry and takes you past some historic buildings and even a steamboat sunk in the river. We saw a bighorn ewe and baby on the trail


trail leads to a small cave that has walls built of stone. It was a fun little walk.

Grand Canyon Lodge The Grand Canyon Lodge is great they have water-bottle filling stations, tons of rooms and cabins, a deli, gift shop, coffee shop (coffee and pastries), saloon, and a fantastic restaurant. You need reservations for the restaurant.

Bright Angel Point Trail

After a delicious meal, we walked out the Bright Angel Point Trail to some absolutely gorgeous views of the Grand Canyon at sunset. This trail is paved, but there are areas with steep drop-offs and no hand rails. We passed several people who were a bit panicked by this. If you have kids along, make sure you keep hold of them at all times on this trail. But the views, especially at sunset, are glorious and totally worth the short walk.

You Won't Regret This Trip We covered 1068 miles on this trip and had a blast. All of the trails we went on were short but pretty, so we had time to see every viewpoint in the area in one day. Let me add that the internet in Page is a bit slow, and in Marble Canyon and the North Rim it is non-existent. Cell service is also very spotty. So, be prepared to be out of touch, and just enjoy some of the most beautiful country in Arizona. You won't regret this trip.





During Extreme Drought AZGFD Assists Thirsty Wildlife

Text SENDWATER to 41444 to help AZGFD conserve, protect wildlife.

Water is the essence of life and it's just as precious for Arizona's wildlife.

For that reason, the Arizona Game and Fish Department has trucked or airlifted about 600,000 gallons of precious water to catchments throughout the state since January. And trail cameras tell the tale of this important work with footage of elk, deer, bighorn sheep and countless other species leaning over for a refreshing drink at one of 3,000 catchments maintained by the department.

"Water catchments don't discriminate - they're used by all wildlife from big game to some of the smallest squirrels, lizards, birds, bats and even bees," said Joseph Currie, AZGFD Habitat Planning program manager, who oversees the department's water catchment efforts.

"Our crews typically stop hauling water in August after monsoon rains refill much of our water catchments. However, due to this extreme drought, we haven't stopped and anticipate having to haul more than 1.5 million gallons of water this year."



To help defray rising costs of providing life-sustaining water for Arizona's wildlife, AZGFD recently began its "Water for Wildlife" donation campaign to give the public an opportunity to support its efforts by texting SENDWATER (one word) to 41444 from any smart phone. After doing so, a link with the department's logo will be sent to the phone to complete the donation.

Funding raised ensures that the department can still deliver water to remote regions of the state and help mitigate population fluctuations caused by severe lingering droughts.

"Historic drought periods such as this one were typically followed by massive die-offs of wildlife," Currie said. "By hauling water, we are able to stabilize those populations, keeping them alive and

AZGFD: June A Busy Month For Nuisance Bear Calls

At the beginning of June, officials at the Arizona Game and Fish Department (AZGFD) predicted the state would see a lot of nuisance bears entering populated areas in search of easy food. That forecast proved accurate, as the state wildlife agency dealt with more than 200 reports of bear activity from more than 50 Arizona communities between June 1-30.

Remove Bear Attracters

While bear calls also were received by County Sheriff's offices, state and local police, and Tribal law enforcement and wildlife agencies, Game and Fish received 206 calls about nuisance bears in June. According to AZGFD Flagstaff Regional Supervisor Scott Poppenberger, the majority of these calls are resolved when homeowners remove things that attract bears or they scare the problem bear away.

"On most bear calls, we counsel the person who reported the incident to make their property less attractive to bears by taking the pet food indoors, removing bird feeders, hazing bears to scare them off and securing trash until pick-up day," said Poppenberger. "As with most wildlife interactions, there's always something we humans can do to make bears stay away."



Each Bear Assessed

In June, AZGFD captured a total of 20 bears that were causing damage in populated areas. Seven of those bears were repeat offenders or so aggressive they had to be euthanized. The euthanized bears

out of urban areas in search of water."

While AZGFD partners with many great wildlife groups, the department bears much of the costs to haul water to and maintain about 1.000 of its own catchments statewide, some of which must be filled with water flown in by helicopter. Additionally, the department also maintains an additional 1,000 Bureau of Land Management and 1,000 U.S. Forest Service water catchments.

for the class and fingerprinting, etc. Once you get your CCW, don't let that be the end of your training. Shooting is a perishable skill - take classes and shoot regularly.

Another Good Reason

Another good reason to have a CCW is reciprocity with other states. You can find a list online, and many states honor Arizona CCWs. Some states have a written agreement with Arizona and some recognize the permit without a written agreement. Some just flat do not recognize an Arizona CCW. It's your responsibility to contact the states you plan to travel in or through and find out for sure.

Federal Gun-Free Zones Schools

The Federal Gun Free School Zones Act makes it a crime to knowingly possess a gun on the grounds of public, parochial, or private school *unless* the in-dividual is licensed by the state. Since school grounds are legally defined as school property and everything within a

raided campsites, emptied freezers, knocked over garbage cans, broke into structures, killed chickens, camped out in dumpsters or tried to enter homes and other buildings. Wildlife managers assessed each bear's aggressiveness and behavior and determined each bear was a threat to public safety.

Bears Can Travel Far

Fourteen bears were relocated to specially selected bear release sites well away from human development, but relocating a bear doesn't always deter it. Two bears were recaptured when they returned to populated areas. A nuisance bear captured in Vernon and released in the wild showed up in Forest Lakes two days later, a distance of about 60 miles. That seems amazing, but according to Poppenberger, a cub first captured in Flagstaff traveled even farther.

"A mother bear and two cubs were captured in Flagstaff and relocated east of town on a Sunday," said Poppenberger. "Four days later, one of the cubs was found in Kingman, a distance of at least 90 miles. If a 15-pound bear cub can walk 90 miles in four days, imagine how difficult it is to keep an adult bear in the woods once it has become accustomed to human food.3

Keepers Of The Wild Nature Park

The cub picked up in Kingman was placed with Keepers of the Wild Nature Park, an Arizona exotic animal rescue facility located near Valentine. The mother bear and the other cub haven't turned up. For the month, AZGFD answered 206 bear calls and euthanized seven bears, or fewer than 3.4 percent of nuisance bears reported.



The fifth reason to get a CCW permit is that it makes it so much quicker and easier to buy a firearm. Instead of the background check and the wait that goes with it, you just hand over your driver's license and CCW and you're good to go. There are also some very confusing websites out there about National Parks, city parks, state parks, etc.

My advice is to call before you go and find out what their policy is. Or see if you can find the rules for that specific park online. Things change all the time, and you are responsible for knowing the law and for your own actions, so get a CCW and keep current on firearms laws.



thousand yards of school property (except private property like houses), you can see that you could technically be in violation of the law nearly all day every day if you don't have a CCW.

Our Arizona Attorney General Mark Brnovich issued an opinion that this law does not apply to private schools. Also, Governor Doug Ducey signed a bill preventing a school governing board from prohibiting someone from legally possessing a deadly weapon on a public right

of way adjacent to a campus I have researched this school thing

extensively, and have simply come away confused. As far as I can tell, firearms in school parking lots are only legal if they are unloaded and remain in the vehicle under the control of an adult, and if unattended, the firearm must be out of sight and vehicle locked. In this case, I think it's better to be safe than sorry, at least if you're actually in the school parking lot or grounds.

Establishment That Serves Alcohol

It's also illegal in Arizona to carry a weapon into an establishment that serves alcohol unless you have a CCW permit and you're not drinking alcohol. How-ever, if the establishment has a sign forbidding weapons, you have to honor that sign. That's the rule at any establishment, store, etc.

Regardless of whether you have a permit or not, if there is a sign saying "no guns allowed", don't take your gun in. Contact the store and let them know you'll be shopping elsewhere, and why. You'd think they'd be happy to have good guys with guns inside, but what the heck. There are plenty of places that don't forbid guns

soak into the wood fibers rather than sitting on top. Thus they do not change internal dimensions. Allow the finish to dry completely as per the directions prior to reassembly.

Trigger Pull

An often-targeted area for improvement is that of trigger pull. A good or bad trigger has absolutely no impact on the inherent accuracy of the gun, but it has ev-erything to do with an individual's ability to shoot the gun to their individual level of proficiency. By this I mean that not ev-eryone practices enough. Not everyone is coached on how to shoot well, and not everyone has the same level of ability. I would love to be able to throw a 90-mileper-hour fastball with pinpoint control ...

however, back to triggers. This area of gunsmithing has changed through the years. Triggers were once of the old type factory, or military type, and any modification required an experienced gunsmith. Then came the age of factoryadjustable triggers. These permitted a degree of tinkering by lay persons to allow for lightening the pull (sometimes to unsafe levels for several reasons). As a result of either past litigation, or some-times fear of future litigation, the factory triggers were made almost tamper proof, as well as having terrible trigger pulls.

By terrible, I do not only speak of the weight of the pull, but also of excessive take up, long over-travel and gritty engagement. Consumers demanded better triggers, and some mechanical design

lever must allow continuation of the sear movement to keep the top from dragging. Drag is further minimized by the angle at the back of the sear engagement. This is over travel. Too much over travel allows for movement in excess of what is required for proper follow through, increasing movement and hurting consistency and accuracy of the shooter.

How To Improve The Trigger

While understanding these functions and how they are accomplished are important, modifying them is also not part of the realm of the new home gunsmith, and will likely be very dangerous. Changing an angle, reducing engagement, or polishing through surface hardening can easily result in an unsafe firearm. So what do we do to improve our gun's trigger?

Fortunately, there is a safe answer. Install an aftermarket trigger. Most aftermarket triggers are fully contained in a housing with all of the above steps such as cutting and polishing already done. These units have external screw type ad-justments for take up, sear engagement and over travel

Set the trigger for use in the real world. If this is primarily a hunting gun, remember you will be carrying it in rough terrain in cold weather. Having a crisp, safe trigger is far more important than having a super light trigger that you will not be able to safely control.

Safety Checks

There are some safety checks that you must make anytime that you work on internal mechanisms of your gun. First, you must absolutely ensure that the gun is empty. Next, recheck to verify that the gun is totally empty. Cock the firing mechanism, and bounce the butt of the stock flat on a rubber matt, to see if the rifle remains cocked. Pull the trigger to ensure that the sear releases cleanly.

Recock the mechanism and cycle the action briskly to ensure that it remains cocked. Engage the safety and pull the trigger hard to insure the safety functions. With your finger off the trigger, take off the safety. The gun should remain cocked and the sear should not release. At this time, the rifle should be inspected to ensure the chamber and barrel are clear, and then take the gun to the range, and following all safety rules test fired to verify proper function.

Cockleburrs are particularly good at holding fish, Sam says.

The little cuts and creases in the banks going into coves also receive plenty of attention from Sam. Those little cuts usually have a "stair-step" kind of structure to them, and Sam loves to fish them with a 1/2-ounce spinnerbait with one #6 Colorado blade.

"Sometimes fish just won't bite until they've seen enough," Sam states, "so I usually make a bunch of casts in every direction on these points, and then back off a little and do it again. Sometimes I won't get bit for thirty casts, then I'll catch three fish in a row."

Shattenberg also re-visits the stair-step points going into coves four or five times during the day, because he says you never know when the fish there are going to be active. He runs his spinnerbait down these steps to about 18 or 20 feet, and he makes sure to fish them thoroughly.

Main Secret To Success

The main secret to Shattenberg's success with spinnerbaits is experience. But experience does you no good if you don't learn from it. Sam says if you fish a spinnerbait right, keep the rod straight, and really concentrate on what the blade is doing, you can actually tell when a fish is even near your lure. He frequently predicts strikes, and you have to see it to believe it.

Pay attention to where and how the bites are coming, then concentrate on putting your lure in those places. You'll find that a spinnerbait can be one of your most productive winter lures.

ing results are quite productive.

Boils are performed by a wide range of small to adult size stripers. Adult stripers are only able to stay up in warm surface water for short period of time. They feed quickly on 2 inch shad and then dive down to deep water to cool off before hitting the surface again.

This behavior makes stripers vulnerable to topwater lures when fish are boiling. When they are resting, deep trolling with down riggers works well, along with spoons when the striper school is seen on the graph.

From the Horn downstream, stripers are still slurping on the surface because they target the small shad that were recently spawned and have not found a good hiding place. Shad that were spawned last month have to find murky colored water to be able to hide and survive the constant onslaught of juvenile striper predation. These slurps are seen virtually every day in most canyons. A school of stripers finds a shad pod, comes to the surface for 15 seconds and then goes back down.

An Exciting Day

Anglers awaiting the slurpers see the school and rush to get in range to cast. The hard part is trying to predict where the school will resurface for the next 15 second burst. If the boat is in casting range when the school pops back up, a good cast, beyond the school, will likely catch a fish as the lure is retrieved through the surfacing school.

If they come up out of range, then the boat has to be repositioned again to hopefully be in range when the school resurfaces. It's a real 'cat and mouse' game with the fish winning most of the time. The visual portion of seeing a lot of fish and catching a few makes for an exciting day.

At press time, lake elevation was 3606, and water temperature was 79-84F.




